- 1. ASSUMPTION OF RISK. Participation in or attendance at the Event involves inherent risks and dangers of accidents, personal and bodily injury (including death) and including, but not limited to, any illness or virus exposure that may occur as a result of the COVID-19 pandemic and/or related strains or other communicable diseases), I specifically acknowledge the contagious nature of COVID-19 and/or related strains and other communicable diseases and voluntarily assume the risk that I may be exposed to or infected by COVID-19 and/or related strains or other communicable diseases by attending the Event.
